LOCAL GOVERNMENT ACT 2009

Local Government Regulation 2012 Chapter 8, Part 2 Local Government Meetings and Committees

Division 1A, Requirements for Local Government Meetings Generally

Section 254J Closed meetings

- (1) A local government may resolve that all or part of a meeting of the local government be closed to the public.
- (2) A committee of a local government may resolve that all or part of a meeting of the committee be closed to the public.
- (3) However, a local government or a committee of a local government may make a resolution about a local government meeting under subsection (1) or (2) only if its councillors or members consider it necessary to close the meeting to discuss one or more of the following matters—
 - (a) the appointment, discipline or dismissal of the chief executive officer;
 - (b) industrial matters affecting employees;
 - (c) the local government's budget;
 - (d) rating concessions;
 - (e) legal advice obtained by the local government or legal proceedings involving the local government including, for example, legal proceedings that may be taken by or against the local government;
 - (f) matters that may directly affect the health and safety of an individual or a group of individuals;
 - (g) negotiations relating to a commercial matter involving the local government for which a public discussion would be likely to prejudice the interests of the local government;
 - (h) negotiations relating to the taking of land by the local government under the <u>Acquisition of Land Act 1967</u>;
 - (i) a matter the local government is required to keep confidential under a law of, or formal arrangement with, the Commonwealth or a State.
- (4) However, a local government or a committee of a local government must not resolve that a part of a local government meeting at which a decision mentioned in <u>section 150ER(2), 150ES(3)</u> or <u>150EU(2)</u> of the <u>Act</u> will be considered, discussed, voted on or made be closed.
- (5) A resolution that a local government meeting be closed must—
 - (a) state the matter mentioned in subsection (3) that is to be discussed; and
 - (b) include an overview of what is to be discussed while the meeting is closed.
- (6) A local government or a committee of a local government must not make a resolution (other than a procedural resolution) in a local government meeting, or a part of a local government meeting, that is closed.

Conflict of Interest Obligations

Reference is made to Section 150EL of the Local Government Act 2009. Specifically, the obligation of Councillors when they first become aware they have a conflict of interest to make the Chief Executive Officer aware in writing or if in a meeting, ensure they declare immediately.

EXECUTIVE SUMMARY

The purpose of this report is to update Council of a briefing provided to The Local Authority Waste Management Advisory Committee (LAWMAC) members on the future structural opportunities for LAWMAC to become a "stand-alone" entity separate from the Regional Queensland Council of Mayors (RQCOM) (previously the Northern Alliance of Councils - NAOC), at LAWMAC's March 2021 meeting.

OFFICER'S RECOMMENDATION

That the Committee recommends to Council to:

1. Note the content of the report in relation to the resolution by the Local Authority Waste Management Advisory Committee (LAWMAC) to move towards becoming an Incorporated Association.

BACKGROUND

The Local Authority Waste Management Advisory Committee (LAWMAC) Executive Committee met on 5 March 2021. At the quarterly LAWMAC meeting held 19 March 2021, members were briefed on discussions and outcomes from the Executive Committee meeting.

LAWMAC Chair, Cr Fisher, briefed members on the current position of LAWMAC in regard to the Northern Alliance of Councils (NAOC) transitioning to become the Regional Queensland Council of Mayors (RQCOM) leading to a non-alignment and loss of representation of a number of LAWMAC member-councils within the RQCOM region.

IMPLICATIONS

Cr Fisher and Cr Hassan reported on a recent meeting with Mackay Mayor Greg Williamson to discuss the future of LAWMAC as a sub-committee of NAOC/RQCOM, and communication on this was very positive and supportive however it was also acknowledged by all parties that LAWMAC does not "fit" with RQCOM.

It was flagged that this could be a new and different phase for LAWMAC and that NAOC transitioning to RQCOM provided a great opportunity to consider LAWMAC's future as a "stand-alone" entity.

Cr Brett Muller briefed members on the options of LAWMAC becoming a Company Limited by Guarantee or an Incorporated Association, with implications for Director Duties under the Corporation Act, Constitutional Obligations, Not-For-Profit Status and Liability Protection for Councils and Members.

WATER AND WASTE



LAWMAC becoming an Incorporated Association would be seamless and more relevant and would also be able to seek funding, operate throughout Queensland, and was therefore determined the better fit of the two options.

The status and relationship of Associate Membership was also raised with the outcome that LAWMAC Councils strongly support Associate Memberships and will be looking at different levels of membership (Corporate, Individual etc).

Members resolved that LAWMAC move towards becoming an Incorporated Association and that the Executive proceed to investigate the Incorporation and develop a report for members at the May 2021 meeting.

The "Demo" Website is <u>https://dev.lawmac.org.au/</u> and with further review and feedback DigiTropics will convert it to the full working site at <u>www.lawmac.org.au</u>

Members flagged the concept of alternatively using a much simpler and user-friendly "File Sharing" arrangement for storing and accessing documents for member access.

Questions were raised regarding the purpose and target audience the LAWMAC website hoped to reach plus also the high maintenance required to keep the site up to date, informative and relevant.

Going forward a "DropBox" option plus social media of LinkedIn, FaceBook etc could be more effective and lower maintenance than a dedicated website.

Members resolved to leave the website "as is" whilst a decision on LAWMAC's structural changes is reached and to develop a report for the next meeting on the future of the website in accordance with LAWMAC's future direction taking on board all comments from members today.

Members discussed the concept of including advertising in the newsletter receiving support from Associate Members for the promotional opportunity.

ROSSKO AWARD 2021

Members were called upon to consider a fellow colleague, local government, company or agency for nomination for the 2021 Annual Rossko Award for Excellence in Waste Management in North Queensland with the closing date for submissions set at 30th June.

The "LAWMAC" personalized plate donated back by previous Chair and Honorary Member Alan Wilson is to be included as part of the Perpetual Trophy Rossko Award each year to maintain its presence within the membership of LAWMAC.

In the absence of Cr Andrea Friend, due to illness, the Drain Buddies Presentation was deferred until the May meeting in Cairns.

LAWMAC TECHNICAL OFFICER REPORT

Executive Meeting Report

Jason Grandcourt briefed members on discussions and outcomes of the Executive Meeting 5th March including the future structural opportunities for LAWMAC to become a "stand-alone" entity separate from the NAOC (now RQCOM).

Jason also advised of the Executive Committee review of the Strategic Plan 2017 – 2021 to address the relevancy of the Mission, Vision, Objectives and Strategies and finalise that document. Copies of the final document to be circulated to members.

Jason to develop a report for projected membership fee levels including budget options (with and without an Executive Officer) for review at the May 2021 meeting. **Moved: Cr Belinda Hassan (Mcky) Seconded: Cr Russ Cook (Tsv) Carried: 11 – 0.**

THE FUTURE STRUCTURE of LAWMAC (re NAOC/RQCOM Outcome)

Cr Fisher briefed members on the current position of LAWMAC in regard to the Northern Alliance of Councils (NAOC) transitioning to become the Regional Qld Council of Mayors (RQCOM) leading to a non-alignment and loss of representation of a number of LAWMAC member-councils with the RQCOM region.

Cr Fisher and Cr Hassan reported on recent meeting with Mackay Mayor Greg Williamson to discuss the future of LAWMAC as a sub-committee of NAOC/RQCOM where communication was very positive and supportive however it was also acknowledged by all parties that LAWMAC does not "fit" with RQCOM.

It was flagged that this could be a new and different phase for LAWMAC and that NAOC transitioning to RQCOM provided a great opportunity to consider LAWMAC's future as a "stand-alone" entity.

Cr Brett Muller briefed members on the options of LAWMAC becoming a Company Limited by Guarantee or an Incorporated Association plus Director Duties under the Corporation Act, Constitutional Obligations, Not-For-Profit Status and Liability Protection for Councils and Members.

LAWMAC becoming an Incorporated Association would be seamless and more relevant and would also be able to seek funding, operate throughout Queensland and was therefore determined the better fit of the two options.

The status and relationship of Associate Membership was also raised with the outcome that LAWMAC Councils strongly support Associate Memberships and will be looking at different levels of membership (Corporate, Individual etc).

Members resolved that LAWMAC move towards becoming an Incorporated Association and that the Executive proceed to investigate the Incorporation and develop a report for members at the May 2021 meeting.

LGAQ REPORT – Robert Ferguson

The *Waste Management and Resource Recovery Advisory Group* met for the first time on 23rd February 2021.

- A departmental update was provided by DES on the key priorities for 2021 including the waste levy legislative review, development of an organics plan, the single use plastics ban and various programs/projects including litter and illegal dumping and regional transport assistance program.
- The advisory group endorsed establishing 3 technical working groups to focus on key priorities. EOI will be sought for membership of these groups.
 - Waste levy legislative review;
 - Queensland organics action plan; and
 - o State-wide waste education and awareness strategy.

Waste levy legislative review. There is a legislative requirement to conduct a review of the waste levy legislation prior to June 2022. It is expected this review will commence in early 2021 and will be led by DES. Advance payments to waste levy councils totaling \$143.5 million in 2019/20 will be included in this review.

- The LGAQ Conference (2020) Association Motion 15 Sustainable local government waste management and resource recovery seeks:-*"That the LGAQ lobby the State Government to recommit to the continuation of the advance payments to councils for MSW beyond 2022 and for at least the next State Govt term".*
- The LGAQ acknowledges that councils will require clarification of advance payments beyond the June 2022 commitment in a timely manner to allow sufficient lead time prior to the 2022/23 budget planning cycle.
- A LG technical working group will be established to ensure that local govt is effectively represented in the review of the levy legislation. An EOI process will be conducted mid-March to identify a representative group of council stakeholders.

Annual waste data and reporting

- Councils have raised concerns regarding the current provision of waste data, purpose and scope of the Department's annual reporting requirements, yearly additions/amendments and overall poor alignment of waste data and reporting.
- The LGAQ and several representative councils met with DES on 21 December 2020 to discuss these escalating concerns.
- Agreement was reached to maintain ongoing discussions and develop a way forward to address these concerns.
- A follow-up February 2021 meeting between DES, several councils and LGAQ progressed discussions on the annual survey questionnaire challenges and proposed refinements.
- At the 15 February 2021 Waste Forum DES provided an overview of their new waste data system (data vault) and mapped out a revised plan of engaging with councils during 2021 and beyond.

Queensland Organics Plan

- DES has commenced initial consultation on the development of a Qld Organics Plan with a purpose of diverting food organics (FO) and garden organics (GO) from landfill.
- LGAQ is participating as a member of a State Govt & Waste Industry Stakeholder Advisory Group and met for the first time on 11 Feb and again on 8 March 2021.
- A LG technical working group to be established to ensure that local govt is effectively represented in the development of this plan. An EOI process will be conducted mid-March to identify a representative group of council stakeholders.

North Queensland Tyre Project

- LGAQ is working in partnership with NQROC, DES and Tyre Stewardship Aust investigating the current state of play and waste flows of end-of-life tyres (EOLT) across the Nth Qld region to identify the range of suitable options for their management/use.
- Due to concerns raised in other council jurisdictions, discussions are underway to determine if the project can be expanded to incorporate further higher level analysis of EOLT across Queensland regional settings. Further updates will be provided as to the outcomes of these discussions.

Meeting with Minister Scanlon's Office

- LGAQ met with Minister Scanlon's advisor for waste management and resource recovery on 15 March. Priority topics of discussion centred on:
 - Waste levy legislative review (and advance payments)
 - Queensland Organics Plan
 - Sustainability funding for local government
 - Release of the Queensland Infrastructure report (currently in the Minister's Office for consdieration)
 - Release of the Queensland Indignous Waste Strategy
 - o Importance of statewide waste education and awareness.

Mr Paul Cranch, Lead – Trade and Investment at LGAQ spoke on Investment in Resource Recovery and the Circular Economy

- Decisions to invest may be influenced by the quality of the service that councils provide
- Statistics show that the quality of enquiry handling will improve the conversion rate to actual investment
- However it is difficult to decide how much time and effort should be taken to support investor enquiries
- Identifying legitimate investors can be challenging Paul can assist with a guide/template

LAWMAC Chair Cr Neil Fisher invited Paul to attend the next LAWMAC meeting and present further.

LAWMAC Chair, Cr Neil Fisher raised concerns regarding the clash of dates between LAWMAC's quarterly meetings which have been "set in stone" for many years and the February and August dates of the LGAQ Waste Forums.

Members endorsed writing to LGAQ expressing disappointment in this clash of dates and request reconsideration on those dates in the best interests of Council and Industry Waste Representatives across Queensland.

Moved: Cr Neil Fisher (Rkptn) Seconded: Cr Brett Muller (Crns) Carried: 11 – 0.

Discussion was also raised regarding the location of the LGAQ Waste Forums and whilst of an excellent value the question was raised as to why they are always hosted in Brisbane?

It was proposed that LAWMAC also write to LGAQ raising awareness of the huge regional area of LAWMAC and the benefits of maximising the opportunities of greater representation by hosting one Forum in SEQ and one Forum in Regional Queensland.

Robert Ferguson thanked LAWMAC for the feedback, acknowledged that LAWMAC represented a large part of Queensland and he has taken all comments on board and will raise discussions within LGAQ.

The LGAQ Reports and Updates by Robert Ferguson and Paul Cranch were noted and accepted.

DES UPDATE

Kylie Hughes recapped on the Single Use Plastic Ban Presentation from the previous day's Workshop.

Shopping Bag Packs for Retailers to avoid Single Use Bags; Commitment from Retailers by 2022 with a transitional period for phasing out single use stock items. Election Commitment - Regulation on Waste Management Infrastructure Plans Currently working with SWCO M, CQROC and NWROC re economic developments Two Action Plans in the pipeline:

- Development of Textile Analysis Action Plan
- E-Waste Action Plan particularly focussing on higher order of items, the right to repair before disposal, etc

The Update by Kylie Hughes, Director of Waste Avoidance & Recovery Policy, Office of Resource Recovery, DES Qld was noted and accepted.

WASTE REPORTS – Member Councils LIVINGSTONE SHIRE COUNCIL

- LSC Waste Services is now a 3-member team with one new recruit joining the team managing multiple contractors providing waste related services
- Resource Recovery and Transfer Station Services tender is currently being evaluated and award imminent
- Resource Recovery Centre Principal Consultant award imminent
- Waste Management Strategy Pre draft Community Engagement survey closed on 5 March 2021. Significant interest with 107 responses received
- Draft Waste Strategy ready to go to the Executive Leadership Team for review
- Plastic Free Places program has now commenced in Rockhampton and Livingstone LG's. Plastic Free CQ
- Waste App to be developed
- Time Lapse video to be set up for Yeppoon Landfill will record a period of 5-7 days of waste being disposed to the Landfill face.

ROCKHAMPTON REGIONAL COUNCIL

- Council continue to work on a Business Case for kerbside organics collection
- The construction of Council's second Piggy Back Landfill Cell is nearing completion. Waste placement within this Cell is expected to commence around June 2021
- Construction of the final capping system on the former Gracemere Landfill is scheduled to commence before the end of this FY

- The LFG Management System at the Lakes Creek Road Landfill undertaken by LMS is now operational and performing well
- Council is looking to purchase equipment this FY for the processing of expanded polystyrene and looking to share experiences and outcomes with other Councils

• Council continues to look for a viable recycling option for Solar Panels.

CENTRAL HIGHLANDS REGIONAL COUNCIL

- **Media campaign.** Launched the "give a hoot, report those who pollute campaign". We are also commencing engagement with schools from 1 July 2021 to help with the messaging.
 - Media campaign to increase community awareness regarding the illegal dumping and hotspots within the area.
- **Waste Strategy.** High level draft of the waste provided to council staffers in March. Some major finetuning of data required but on track for community consultation later this calendar year.
 - Shout out to anyone using the Technology one project to reach out and we could look at how your financial layers are set up with reporting.
- **CapEx projects.** 15 projects in the 2020/21 budget totalling \$4.1M. On track to completing all projects on time this financial year.
 - 15 projects identified for delivery in 2021/22 with a budget of \$3.74M being proposed
- Super Resource Recovery Centre. Final investigations going with three identified sites with one being preferable however its proximity to the airport is causing concerns at the moment from a planning perspective. This will be a centralised landfill and resource recovery centre within Emerald as the active landfill at Lochlees (11km from Emerald) is nearing capacity in next 8-12 years.
- Full cost price modelling. New full cost price modelling has been commissioned for 1 July 2021. Last FCP completed in 2017/2018
- Fees and charges. Update to fees and charges to increase the fees associated with some waste disposal. Also seeking to merge the gate fee with the waste levy fee (seeking thoughts from councils for the merge/split of the fees)
- **Staffing.** Struggling with rosters with 8.5 resource recovery attendants staffing 6.5 sites + 6 bin stations (contractors look after 2.5 sites). Geoff is preparing a report to ELT to seek additional staff members to help alleviate this.
- **Community desire.** Communities are seeking more hours for facilities so looking at automated gates and will visit Banana's new facility en route to Gladstone. We have a significant amount of education to help with the community ahead of automation to ensure it works for our facilities.

MACKAY REGIONAL COUNCIL

- On 3 February 2021 Council visited various current waste and resource recovery facilities in the lead up to the waste and resource recovery strategy review.
- Council's collection contractor J. J. Richards & Sons Pty Ltd has experienced a significant number of on board truck fires for both waste and recycling vehicles. Council has undertaken a significant number of releases to communicate with residents on the importance in adhering to Council's acceptance criteria for materials being placed into bins. The rise in the use of lithium ion batteries are a contributing factor.
- Kerbside recycling material continues to be received from Rockhampton and Central Highlands Regional Councils to be processed at the Mackay MRF. This will continue until the MRF at Rockhampton is operational, following the fire in late 2020.

- Several capital and operational projects have been brought forward for Waste Services including replacement of life expired oil recycling sheds, re-sheeting of greenwaste gravel hard stands and the gravel re-sheeting of Hogan's Pocket Rd.
- Council's Closed Landfill Project continues with the awarding of Phase 1 Closed Landfill Rehabilitation Program to Golders and currently procuring a Closed Landfill Auditor.
- Waste Services Asset Management Project is continuing with significant progress with data cleansing and naming structure being completed.
- The very sad news that Council's Resource Recovery Education officer, Fiona Paterson, has resigned to focus on retirement. Fiona has been the core to success with Council's education program, working for Council since 2007. Fiona will be very much missed by Waste Services, Council and the community at large, with her extensive knowledge and willingness to share with others. We wish her well with her next chapter from Friday 2 April 2021.

WHITSUNDAY REGIONAL COUNCIL

- 1. 2021-21 Local Government Levy Ready Grant Program (Round 2)
 - WRC holds a temporary exemption under section 325 of the Waste Reduction and Recycling Act 2011 (the Act) for its Mt Coolon Landfill. WRC was successful in its application for a grant to close the landfill and establish a waste transfer station. Community engagement and project planning is underway.
- Kerbside Waste and Recycling Contract
 Expires EOFY 2021 WRC prepared a short-term contract of <3 years to align
 with Mackay Regional Council with the intention aligning contract expiry dates to
 enable a future joint tender process. This Tender has closed and evaluations are
 in progress.</p>

3. Cannonvale Transfer Station Services Contract

Expires EOFY 2021 – Out to Tender. Currently included in the kerbside collections contract with JJ Richards. This service has been separated out as a separate contract to enable inclusion of smaller local suppliers.

4. Satellite Waste Transfer Stations

WRC operates 14 unsupervised waste transfer stations. Each satellite transfer station represents, and is intended to service, residential properties in geographical areas not currently receiving kerbside collections. Managing these sites is a challenge with illegal dumping and high service costs. Planning is underway to extend kerbside services and progressively close some of these facilities including one site identified as located on private property.

5. QLD DES Regional Recycling Transport Assistance Package (RRTAP)

<u>Concrete recovery</u> completed with the removal and transport of 3463 tonnes of concrete to Mackay for crushing and reuse as road base.

<u>Household Battery Recycling program:</u> Fourteen (14) boxes of batteries weighing 101 Kg were sent to Envirostream for processing with another 18 boxes prepared for transport and processing. Volumes below expectation and targets adjusted accordingly. WRC will continue to run this service post funding.

6. Waste Strategy

The current waste strategy covers 2016 to 2021. Budgeting and planning for development of a new Waste Strategy is underway including discussions with Mackay and Isaac Regional Councils.

CAIRNS REGIONAL COUNCIL

• RDA FNQ Plastics Options Analysis - third stage, Education component, is commencing this week.

- Cairns Council and Tablelands Regional Council have commenced a 3month trial to process TRC kerbside recycling.
- Glass processing facility is now operational with performance testing at the end of the month timing is appropriate as Council has continued to develop local markets for crushed glass as a sand replacement such as:
 - * In collaboration with other FNQROC Councils, Cairns Council has included the utilisation of crushed glass as sand replacement for bedding sand for water and waste water infrastructure and
 - * Through Council's procurement process has invited Asphalt Suppliers into a Preferred Supplier Arrangement to utilise crushed glass as sand replacement in asphalt.
- Portsmith Transfer Station CRCs main Transfer Station planned Capex spend of ~\$1.2M this calendar year. Project will involve the construction of a second gatehouse, reseal of the road network, addition of two drop-off lanes, upgrade of the Cardboard, E waste and Hazardous Waste Collection areas.
- Council is currently undertaking a full review of its website expected to finalise this financial year. Analytics has shown that the Waste and Resource Recovery areas are some of the most frequented sites, as such the new site will have shortcut buttons to the most popular links (ie kerbside collection, Transfer Station information and A-Z of Waste).
- Pleased to announce that at the end of the month Council will be workshopping a Single-Use Plastics Policy

Finally, like to invite all to attend LAWMAC in Cairns on May 20-21. The location for Thursday's meeting is a great example of Reuse. Council has converted an old WWII oil tanks site into multi-purpose venues. Friday's meeting will be at the new MRF.

TOWNSVILLE CITY COUNCIL

- Council is developing a new corporate plan. Circular economy principles are now embedded within the corporate goals.
- Regional Organics Management Roadmap has been developed outlining the pathway to introduce food and garden organic collections and processing as well as identifying/developing end markets. It is expected to enact the Roadmap when there is certainty around the future of waste levy advance payments.
- With 46% organic material in the landfill bin, Council is planning to undertake two concurrent Organics Trials during 2021 / 2022:
 - Fortnightly 240 litre garden organics (GO) bin, weekly 240 litre landfill bin
 - Weekly 240 litre food and garden organics (FOGO) bin, fortnightly 240 litre landfill bin
- A long-term infrastructure plan to support the WARR strategy has been developed and will guide capital expenditure over the next 10 years.
- Recent plant and equipment replacements include a new John Deere Loader, 22 tonne Excavator, 38 tonne Bomag landfill compactor, D6 Case bulldozer, 6X4 water truck with fire fighting capability, and trade certified scales for the telehandler. A cardboard compactor was also recently installed at the Hervey Range Resource Recovery Centre.
- 2020/21 Capital projects have all been completed:
 - Interface liner extension at Stuart for Cell 3A (\$3.5m)
 - Leachate Pond 4 at Stuart (\$4m)
 - Final Capping at Hervey Range (\$4m)

• Gas production at Stuart Waste Facility has doubled with the installation of another 15 gas wells at the Stuart Landfill. Aiming for power generation in 2023.

BANANA SHIRE COUNCIL

- Banana Shire Council has installed and opened the first of its Waste Transfer Smart Stations at Wowan. The opening occurred on the 17th of March 2021. All other sites to come on line post July 1 2021
- Closing of the Cracow Landfill/ Opening of the new Waste Transfer Station with Smart Capability to be completed by June 30 2021
- Option Analysis has commenced for a new MRF/Landfill site within the Banana Shire
- MOU was drafted and disseminated between industry and Council on the use of disturbed mine land for post mining land use for Waster/Recycling facilities
- Development of a Leachate Treatment/Transportation facility at Trap Gully Landfill. Final design completed
- Obtaining quotes for EA development and EA Amendment for existing operations to allow BSC greater capability to except other waste types and to commence trials in composting
- Continued Development of a new 5, 10 and 20 year Strategic Plan
- Planning for the rehabilitation of remaining historic Landfill sites, BSC had 6 historic landfill sites which had not been rehabilitated. Five other landfill sites have now been rehabilitated since the start of 2020
- Construction of the Taroom Waste Transfer Station is near completion and expressions of interest have gone out for staffing of the site;
- Entered an agreement with neighbouring councils for the future use of the rebuilt Rockhampton MRF
- Included in the first CQROC waste committee brief/meeting.
- Closing of the Cracow Landfill/ Opening of the new Waste Transfer Station with Smart Capability

GLADSTONE REGIONAL COUNCIL

Benaraby Landfill second weighbridge was commissioned on the 19/11/2020 and is being used as the inbound bridge to weigh all commercial customers in to site and the original weighbridge has become the outbound weighbridge. Domestic customers are not currently being weighed due to restrictions with are current traffic management plan.

- Benaraby Landfill Traffic management has been highlighted as needing an upgrade.
- Benaraby Landfill new landfill cell 3A is to be completed by the 14/04/21. A fill plan is being developed by ATCW as part of the project and the plan will achieve the following
 - Safe disposal procedures and protection of the receiving environment.
 - Optimisation of compaction and airspace consumption.
 - Minimisation of leachate generation.
 - Management of surface waters.
 - Compliance with conditions of the operational approvals.
- GRC has engaged Resource Analytics to assist in future planning for Landfill rehabilitation and waste pricing models.
- GRC has employed all ex contractor staff that operated at GRC remote transfer stations as part of its in-sourcing program. New staff are being trained in best practices surrounding transfer station bin utilisation and recovery.

- GRC employed an Illegal Dumping Officer in April 2020, since commencement of this position GRC has issued 51 pins and removed 61,705ltrs of illegally dumped materials.
- GRC are currently operating one Landfill and eleven Transfer Stations.
- GRC to hold Ecofest on Sunday the 6th of June. Ecofest is Gladstone Region's annual environmental festival celebrating World Environment Day. The theme for this year's event is **Ecosystem Restoration**. Ecofest aims to encourage and empower the community to make changes towards being more sustainable.

BARCALDINE REGIONAL COUNCIL

- Through our strategic planning, BRC is investigating reducing its five town landfill sites back to two.
- With the purchase of a new truck being budgeted next financial year, BSC is investigating whether to continue performing kerbside collection inhouse or move to external contract.
- BSC is also investigating whether to operate the new Barcaldine Transfer Station or contract that out also.

COOK SHIRE COUNCIL

As reported by Sheils Barra at previous LAWMAC meeting Council was exploring options for collection and transporting waste from Lockhart River Aboriginal Community however with only a couple of metres of waste this is proving too costly.

This is an ongoing problem for Council and is currently servicing from Coen every ten days to pick up. Very expensive and Council is unsure what to do at this stage – possibly go back to a small landfill?

Business as usual in all other areas of waste management at Cook.

NORTH BURNETT REGIONAL COUNCIL

Mayor Rachel Chambers thanked LAWMAC for the invitation extended for NBRC delegates to attend this event and briefed members on the population of 10,000+ residents over five townships with NBRC included as a Waste Levy Council.

Due to the costs to the Community and huge shifts in how waste is treated NBRC decided to be part of a Zero Waste Economy but need help to identify the right fit and LAWMAC Councils may be able to provide some of those answers.

NBRC currently does not recycle cardboard and do not have a yellow bin system and would definitely need community waste education to avoid contamination levels.

Risk Assessment is underway at the Waste Transfer Stations and Council is looking at networking with other councils for feedback plus also consider addressing the issues of unmanned facilities.

NBRC is considering On-Site Micro Solutions as they do not have the size and scale to transport waste economically.

Farm products coming into landfill and how to address this is also an issue for NBRC.

North Burnett Regional Council expressed interest in becoming a LAWMAC member-council in 2021-22 and Mary to liaise and advise membership options and fees.

MAREEBA SHIRE COUNCIL

- Reviewed and updated the Full Cost Pricing Model Waste, includes the feasibility of a kerbside recycling service
- Review and rationalise transfer station operating hours and operating model
- Review fees and charges
- Exploring the opportunities for a buy back shop
- Commencing mattress recycling program with Endeavour Foundation

• Commenced household battery recycling program which to date hasn't had the uptake expected

ISAAC REGIONAL COUNCIL

- Annual Mandalay training & system development week commencing 8 March shared with Central Highlands Regional Council
- New version of Cleanaview software launched in week commencing 8 March
- Tender for processing of green waste and certain other wastes at Council's three largest sites closes on 1 April

WASTE REPORTS – Associate Members RESOURCEHUB

- Preferred partnership model with Mandalay has commenced, and announcements regarding service offerings will follow in coming months. At this stage, RHC (Resource Hub Consulting) has been announced as Mandalay's preferred partners for on the ground disaster response and preparedness services. With a team of 4, we're excited to be adding further resources to the services to date delivered by Lacey.
- We have commenced ongoing remote administrative services for a number of council's including Lawmac members, providing outsourced Regulation/Waste Levy reporting. RHC supports councils by actioning levy reporting collation and lodgement on their behalf, and acting as transactional data administrators, where waste teams are understaffed or have other priorities.
- We will be meeting Minister Scanlon and her advisory team in early April to provide guidance in regard to some of the limitations of RRIDP program and the effectiveness of other grant programs across the states that are suitable for smaller scale resource recovery projects.
- For council's who work with the Sustainable Schools Network, Resource Hub has been engaged to support the organisation through a change in business operations. Touch base for more details.
- Waste Levy update DES is continuing data audits across ALL facilities and if you haven't been asked to provide supporting information for July2020 to December 2020, expect to be contacted shortly. Lacey is currently supporting 6 council's with responses in repeatable formats that can be used in future. Our recommendation is that if you are providing evidence of changes to past returns or providing guidance in regard to data queries, do so in a spreadsheet format, with a single tab per TYPE of query, and include transactional information as well as a description of onsite operational process as supporting evidence.

BENETERRA

- A breakthrough with the Department of Environment and Science with respect to how to gain an approval for evaporative technology such as BeneVap in a Queensland landfill. The issue stopping such approvals was the lack of regulation around air emissions limits for PFAS compounds. DES has committed to following a similar risk based approach as in other states with EA conditions likely to include a "measure and report" requirement on PFAS and other contaminants.
- BeneTerra is looking for councils who feel that a change to their EA conditions to allow for this type of technology choice would be advantageous.
- After the first of the councils gets their updated EA conditions, then we will be looking for industrial clients to follow suit.

• In addition to BeneVap, BeneTerra is engaging with landfills both in Australia and overseas to offer a number of other services including QA/QC roles for geofabric installations and plastic liner repairs and welding.

ENVIROSCIENCE MATTERS

Projects underway include:

- Advising a Victorian Auditor on technical aspects of phytocap design for a large city landfill east of Melbourne;
- Design of a phytocap for a reginal landfill in southern NSW;
- Finalisation of the design of an effluent irrigation area using a combination of trees and fodder grasses for a Council in southern NSW;
- Preparing a Rehab Plan using phyto interception as the moisture control method on a waste site in the wet tropics;
- Installing gas and leachate monitoring wells on a waste site in the wet tropics.

ESM and PhytoLink continue to work with Dr Ruby Michael and her students at Griffith University on a variety of research projects including tree water uptake.

CLEANAWAY

- Cleanaway in QLD has had a busy start to the year:
 - Commenced Banana Shire kerbside collections on 1st January 2021
 - Re-won Douglas Shire kerbside collections, from 11th January 2021
 - Commencing Logan City Council on 1st July 2021
 - Tendering for Whitsundays, Fraser Coast, Gold Coast, Sunshine Coast
 - Large commercial customers now include Coles, Woolworths, Telstra, Collins Food (KFC, etc), EA Fuels (Caltex)
- COVID impact:
 - Interstate movements hampered over concerns of snap border closures
 - 9 month wait list for cab chassis out of Europe / Japan.
 - Spares supply shortage from Europe = vehicles off road for longer.
- Other:
 - Steel prices markedly higher = expensive bins = inflation.
 - Former Cleanaway RM Chris Ashton currently battling an aggressive form of Leukemia members wished Chris well.

MAMS GROUP

DIRECTORATE HIGHLIGHTS

- The W&W Leadership Team held the first of four Cultural Leadership Program sessions with all W&W employees in Nebo on Thursday 8 April 2021.

Emerging Risks

- Pump Station Overflows we are in receipt of a "show cause" from DES regarding an SPS overflow at Dysart as well as a request to update compliance documents following a SPS overflow at Clermont. A review of our compliance with our Environmental Authority and ERA63 for SPS's shows our documentation is non compliant and we are lacking some essential documents. We are anticipating a direction from the regulator as expect we may be required to fast track environmental plans such as site based management plans and environmental management plans etc. 20/21 budgets are being reviewed for capacity to fund the required works. We will take this opportunity to set meaningful long term improvement plans for SPS's.
- Moranbah Landfill Remediation work continues with the new superintendent to finalise this project. Without
 Prejudice discussions scheduled with contractor early May and we anticipate further direct supply of
 materials to complete the contract.

BUSINESS SERVICES

PREVIOUS MONTH'S ACHIEVEMENTS:

- IMS Internal Audits were completed at Carmila and Greenhill Waste Management Facilities in preparation for the October External Surveillance Audit. These audits help embed the IMS principles across all our W&W sites and identify opportunities for improvement.
- The W&W Leadership Team Cultural Leadership Program first of four sessions with all W&W employees was completed in Nebo.
- The IMS Quarterly Management Review occurred this month. These reviews provide the management team
 with invaluable insights into how the Directorate is tracking against their IMS goals and responsibilities and





Theresa Creek Dam Wall 30 April 2021






St Lawrence Water levels. Note: 24mm of Rainfall recorded at St Lawrence Township during April.




St Lawrence Weir as of 28 April 2020

Nebo Bore number 2 water levels. Nebo has received 48mm of rain during April 2021




Waste Tonnage and Waste Levy

The following diagram shows a comparison of the waste levy paid in 2020-21 compared to 2019-20. There has been a significant decrease during 2020-21, despite the \$5 per tonne increase from January 2021. It is probable that reduced mining activity around Moranbah has resulted in less waste from mines at the landfill. Officers are forecasting an annual landfilled tonnage of just over 30,000 tonnes for 2020-21, down from 32,000 tonnes in 2019-20.






This graph also illustrates the impact of this waste reduction on revenue being raised from landfill gate fees.




This graph shows a comparison between the past 4 years by Quarter.


Kerbside Waste Collection. This graph illustrates the participation rates for both the red-top and yellow-top services in the year to date

PREVIOUS MONTH'S ACHIEVEMENTS:

Significant Projects Update:

5 ML Reservoir Opening

Thank you for attending the opening, even though there were few public members attend the acknowledgement of the team and contractor was valuable. There are definitely lessons learnt from the project for which the formal process has not occurred yet. Punch list of outstanding items was completed 28 April 2021. Project now completed, with finalisation process now underway.

CW212861 Water Mains Replacement – Lime and East Street

This project has reached practical completion which was issued on 21 April 2021. The contractor has demobilised with the new water mains are fully operational. This project was completed on time with budget savings on the contract value. There was some public impact while minimal and when the wet weather event occurred with scouring of materials being washed away. Rectification works was required, and the team worked the environment office to reduce impacts. Overall a good project.





CW202807 Theresa Creek Dredging Project

The dredging project is progressing well with volumes being extracted on track with program. There has been some extent of rock being retrieved which differs from the as constructed plans. There has been approximately 4000 cubic meters removed with 12 geobags being filled at the moment. There is residual funds available with negotiations occurring to extract additional volumes to fully utilise funding monies. Any additional scope will follow the variations process with approval and signoff.

CW182564 Capricorn Reservoir Project

The leak on the overflow pipe was repaired by the contractor, unfortunately it has not completely solved. Currently waiting for the contractor to provide a new methodology on how the rectification will occur. It is important that the solution provides a robust long-term solution not just a band aid which may require ongoing maintenance. Commissioning of the reservoir has been put on hold until such time that the leak is fixed.



CW202809 Moranbah Landfill Remediation

Project awarded at Ordinary Meeting 28/04/2020 to Synergy Resource Management. Revised project estimates now \$5,000,000. Current expenditure is sitting at \$2.6M Contractor has completed the land fill reshaping, supply and placement of cover material, and is now placing the clay capping approx. 90%. Agreement has been reached for the Principal to supply the project topsoil due to issues between the principal contractor and the local sub-contractor supplying the material. Progress has been slow, with the contractor is likely to be 6 months late in the delivery of this project. The delays have been caused by slow progress within all stages of the work due to construction issues, and contractor inexperience. The contractor has been encouraged to improve their productivity. A new external Superintendent has been appointed to assist with the closing out of this project. The Project Team has also concerns relating to the financial stability of the Principal Contractor, with legal advice sought to address this issue, and other project issues currently being experienced. The contractors revised program has PC and 19 May 2021. However, the project team don't expect this work to be completed before mid-June 2021.

There is a 'Without Prejudice' Meeting to occur Tuesday 4th May between the contractor, Superintendent and IRC representatives.

CW182580 MBH STP – Belt Filter Press

There has been good progress made on this project. There is currently a variation being considered which has been driven by trying to respectively install equipment which was bought and housed in a container for 5 years with some missing pieces and some failed.



CW182537 400ML Raw Water Storage Dam

The offer from the Department has been accepted and the deposit paid in order secure offer prior to lapse date. Currently we are working with Manager of Procurement who have engaged knowledge expert in native title to manage the conditions of the offer.

As at 23 February 2021, Waste Services actual expenditure totals \$2,915,411 representing 50% of annual approved budget (20-21 - \$5,925,687 adjusted down @Q2 to \$5,794,510), and a total spend inclusive of tender commitments of \$5,537,097 which represents 95% of annual approved budget.

The combined Water & Waste actual expenditure totals \$9,425,634 representing 48% of annual approved budget (20-21 - \$20,093,605 adjusted down @ Q2 to \$19,279,570) and a total spend inclusive of tender commitments of \$16,396,366 representing 85% of annual approved budget.


